professional driver instruction, consisting of one hour vehicle familiarization, plus 4 lessons. A lesson consists of 1 ½ hours of professional Behind the Wheel Driving instruction. The North Florida Safety Council (NFSC) will furnish the vehicle for all practical instruction. The Behind the Wheel portion of the program will give practical road experience with a qualified, certified instructor. The Drivers Ed student agrees to attend classroom instruction consisting of a 4-hour National Traffic Safety Institute Defensive Driving Course and a 4-hour Traffic Law and Substance Abuse Course if needed. The courses are included in the program fee. The parent/guardian also agrees to provide no less than 50 hours of additional behind the wheel driving practice. An affidavit by the parent/guardian is required by the Department of Highway Safety & Motor Vehicle (DHSMV). The student will be required to complete home study of the Florida Drivers Handbook. An additional fee will be charged for residential pick-up and return.

Each student must have a learner's permit prior to actually driving. This permit must be carried at all times for each lesson. Students without a learner's permit will be scheduled into a Traffic Law and Substance Abuse course conducted by NFSC. This course satisfies the DHSMV education requirements to obtain a permit.

Appointments for lessons will be scheduled based on instructor availability and by mutual agreement between the student and the instructor. Once scheduled, appointment must be cancelled 48 hours in advance to avoid forfeit of a lesson. A rescheduling fee of \$50.00 (in addition to the program fee) will be charged for appointments cancelled with less than 48 hours notice.

The NFSC will not refund any tuition or part of tuition if the NFSC is ready, willing and able to fulfill its part of this contract.

**It is agreed that an owner, instructor, agent, or employee of the NFSC shall not give the impression to a student that upon completion of their instruction, the NFSC will guarantee the securing of a driver's license**
